As such, the ICOPED conducts CDA-prescribed training courses for cooperatives.</p> <p>This course is designed to develop and enhance the knowledge and skills of the Treasurer, Audit Committee and general manager on the different cooperative standards prescribed by the CDA. Upon the completion of the course, participants are expected to explain the concepts and purposes of the prescribed Cooperative Standards, to explain the indicators and the accounts in relation to the operation and services of the cooperative, and to analyze the operations of the cooperative based on the standards.</p> <p>This course has been conducted once from 2011-2016.</p>
